## Ludovic Luzza appointed General Manager of Generix Group North America

I am committed to placing customer satisfaction at the heart of the North American subsidiary's development strategy and - in particular thanks to our partners - to extending our presence to new customers in our priority sectors (Industry, FMCG, Retail and e-commerce and 3PL)" commented Ludovic Luzza.

<u>Ludovic Luzza</u> holds a degree in Accounting and Finance and started his career in 2002 in the retail industry. He was then Audit Manager for Mazars in Lille from 2004 to 2009. Ludovic joined Generix Group in 2009, from which date he has led an in-depth transformation of the financial and administrative organization, in order to support the daily performance of the business units and Generix Group's exposure on its markets. He was also at the forefront of the Group's acquisition projects, notably Sologlobe in 2016 in North America, until his appointment as head of the subsidiary today.
